A Fresh Start with a Firm Foundation

In June 2025, a new Board of Directors was seated to restore financial accountability and operational oversight. The Board unanimously voted to continue school operations for the upcoming year, contingent on a plan that is both fiscally responsible and spiritually centered.

The 2025–26 plan includes:

- Enrollment Goal: 27 students
- Staffing: 4 dedicated teachers, 1 administrator, and faithful volunteers
- Curriculum: Classical Christian education with proposed enhancements
- Tuition: \$6,500/year, payable in full or over 12 monthly EFT or credit card drafts

Financial Transparency & Strategic Planning

Our budget reflects a lean, mission-driven approach with a long-term goal of growth and strength.

Projected Revenue:

- Tuition (27 students × \$6,500): \$175,500
- Fundraising Events: \$70,000
- Sponsorships: \$55,000
- Community Donations: \$20,000

➡ Total: \$320,500



Projected Expenses:

- Personnel: \$152,000
- Curriculum & Overhead: \$32,100
- Debt & Back Salary Repayment: \$129,476
- ➡ Total: \$313,576

Any surplus funds will be used to repay unpaid teacher salaries from the 2024–25 year—a top priority for our board and school family. Vendor obligations will also be addressed as funds become available.

Our Mission: Minds, Bodies, and Spirits

Faith Academy exists to partner with parents in providing a Classical Christian education that nurtures the whole child—mind, body, and spirit. We believe that academic excellence, spiritual formation, and moral character are inseparable, and we are committed to a school environment that reflects Christ in all things.

Curriculum updates under consideration include:

- Grammar School (K–4): Memoria Press, Singapore Math, Gospel Story Bible
- Logic & Rhetoric (5–11): Saxon Math, IEW, Apologia Science, Summit Ministries, Omnibus
- Online classes may be used to fill instructional gaps as needed

Final curriculum decisions will be made at the July board meeting, with faculty and family input welcomed.
