

# **Summary of Bylaw Amendments**

Faith Academy of Freestone - Adopted 2025

The Board of Directors has adopted the following key amendments to the school's Bylaws to support clear governance, legal protection, and operational integrity:

- 1. Board Size Flexibility
- The number of Directors may now range from 3 to 9, providing flexibility for organizational needs while ensuring quorum and leadership continuity.
- 2. Strengthened Indemnification
- Directors, Officers, and agents are now explicitly protected to the fullest extent of Texas law from liability related to their service, provided they act in good faith and in the best interest of the school.
- 3. Clarified Governance Procedures
- Language throughout the Bylaws was updated for clarity and simplicity, making it easier to follow nomination, election, and meeting procedures.

These updates reflect Faith Academy's continued commitment to strong governance, transparency, and stewardship. A full copy of the revised Bylaws is available upon request.

## Scope

Day-of-month change only; all other provisions (time, notice, location, quorum, participation, rescheduling authority, and parliamentary procedure) remain as previously adopted unless amended elsewhere.

## **Effective Date**

Upon adoption of the accompanying Board Resolution, unless a different effective date is specified in the motion.

#### **Administrative Notes / Remarks**

- Update the public/parent calendar, Board standing calendar invites, website, and any posted notices to reflect third Monday cadence.
- If the scheduled date falls on a federal or church-observed holiday, the President (or designee) may reschedule per notice provisions.
- Coordinate with First Baptist Church for facility scheduling to avoid conflicts.
- If adopted in August 2025, the first "third Monday" would be August 18, 2025.
